The annual subscription is Rs.2000/- per annum, one representative nominated by them will be included in Central Council.

The admission fee will be Rs.500/- payable once only at the time of joining / rejoining AISCCON, in each case.

Central Council of AISCCON is authorized to change all types of Membership subscription on the recommendation of the Executive Committee from time to time.
