3. Secretary Organization – 1 Post
4. Joint Secretary Organization – 1 Post
5. Joint Secretary – 4 Posts

No election will be held by the Returning Officer for the following posts as the posts may be nominated by the Central Council in its meeting.

1. Vice President – 2 Posts (One Post will be for a Female)
2. Secretary General – 1 Post
3. Secretary, Finance – 1 Post
4. Addl. Secretary, Finance – 1 Post
5. Joint Secretaries – 4 Posts (One Post will be for a Female & One Post will be to assist the President)
6. Chairman, AISCCON News Council – 1 Post

Fill it properly and send to the **Returning Officer, AISCCON – Election 2019, Jyeshtha Nagarik Bhavan, Plot 7C, Sector 12, Behind Gaondevi Mandir, Nerul (W), Navi Mumbai 400706** by Speed Post / Courier/ Regd. Post /Hand delivery so as to reach him by **5 p.m.** on or before **10<sup>th</sup> August 2019**. Nomination Form should be filled completely. No space should be left blank in the form. Name, Address, Phone Number/ Mobile Number, Membership Number, Date and Signature should be filled properly. Proposer and Secunder must be different members of Central Council of AISCCON. A Central Council Member can propose or second for any number of Posts.
