These Individual members get AISCCON News for lifetime and are eligible to come in Central Council through their category in pre-decided proportion by election every three years. Central Council is the General Body of AISCCON.

III) For Institutions (Gerontological, Old Age Homes etc)

The annual subscription is Rs.5000/- per annum, one representative nominated by them will be included in Central Council.

The admission fee will be Rs. 2500/- payable once only at the time of joining / rejoining AISCCON, in each case.

Central Council of AISCCON is authorized to change all types of Membership subscription on the recommendation of the Executive Committee from time to time. Above mentioned subscription for 2020/21 from Federations / Associations / Institutions is payable on / before 31st May 2020. Payment of Annual Subscription after 31.05.2020 will attract late fee of Rs.100/- for each defaulted year. **This apart, they will not be eligible to vote in elections.**

You are also requested to pay annual subscription for 2019/20 and / or previous years if not paid earlier. Please include Rs.100/- as late fee for each year, along with this payment.

Paying annual subscription regularly is essential since the representatives of those Federations / Associations / Institutions paying subscription regularly and upto 31st May alone will be included in the list of Central Council of AISCCON each year or voter's list in the election year.

We request you to please re-confirm your representatives on the Central Council.
