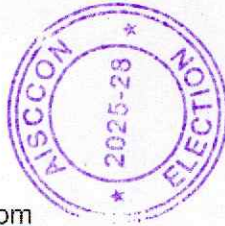
No hard copy of nomination form will be dispatched by the Returning Officer as it could be downloaded from the AISCCON WEBSITE www.aisccon.org
